1.  - Disclose information about your proposed loan and your credit information to a guarantor or prospective guarantor.
4. FSO, as your agent to do any, or all, of the following on your behalf to access and disclose your credit information;
 - Provide your identification details to a credit reporting agency
 - Obtain your credit report from a credit reporting agency
 - Disclose information from the credit report and any relevant credit information to a lender /lenders originators we have association with
 - Disclose information about your proposed loan and your credit information to a guarantor or prospective guarantor.
